T2 sycamore, rear right, Large, decayed monolith. The suggested works are: To fell to ground level by sectional takedown. Grind down stump to approx 200mm below ground.  
T1 Sycamore, rear rightside of the garages. Large, mature tree. This tree is outgrowing its location. Fell to ground by sectional takedown and treat stump.  
T3 Limes, These trees overhang the garages and the leaf fall is blocking the gutters and causing water to get inside the garages. The suggested works are: To crown lift both trees to give a 2m clearance above the garages. Reduce the overhanging lateral spread by 2m.
