T1 Lime x 2

Large, mature, previously reduced trees. To maintain these two trees, the suggested works are: To reduce back to the most recent points of reduction, retain shortened furnishing growth for crown continuity, remove up to 50% of fine internal growth, remove deadwood, trunk and basal growth

Front, left

T3 Sycamore x 1

Large, mature tree. This tree has had some low lateral pruning carried out in the past. The main union is a compression fork union with included bark. This type of union is prone to failure under mechanical loading. The union has significant reaction wood on the Northern side of the tree. This suggests that the tree is struggling with the loading through this union. In order to reduce the mechanical loading, the suggested works are: To reduce the overall height by 3m, reduce the lateral spread all round by 2.5-3m, clean out crown, remove deadwood.
