ENFORCEMENT NOTICE

OF 12 EGBERT STREET LONDON NW1 8LJ

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to it that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. It considers that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at 12 EGBERT STREET LONDON NW1 8LJ ("the Property") as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without planning permission the installation of lamp, three (3) x security cameras and one (1) x alarm box on the front elevation at ground floor level

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last **4 years**.
- b) The cameras, alarm box and light on the front elevation of the building, by reason of their location and appearance and cumulative impacts adds harmful clutter and forms an incongruous and obtrusive set of features which are harmful to the character and appearance of the building, the streetscape and the Primrose Hill Conservation Area. As such, the works are contrary to policy CS14

(Promoting high Quality Places and Conserving Our Heritage) of the London Borough of Camden Local Development Framework Core Strategy; and DP24 (Securing High Quality Design) and DP25 (Conserving Camden's Heritage) of the London Borough of Camden Local Development Framework Development Policies.

The Council does not consider that planning permission should be granted because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of three (3) months of the Notice taking effect:

- 1. The existing security cameras (x3) and lamp shall be completely removed from the ground floor front elevation and any resulting damage caused shall be made good.
- 2. Completely remove the alarm box **or** relocate it to its previous position at first floor level on the front elevation shown on plan 7419-04-a approved under application ref. 2014/5248/P and make good any resulting damage caused.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 5th April 2016 unless an appeal is made against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002
