Rear Garden:

Bay - Reduce crown by approximately 30%. Thin crown density by 20%. This will be a somewhat harder prune back than previously carried out. It may leave the tree temporarily a little bare.

Pear: Adjacent boundary wall. Tip prune reduce by 15%.

TPO Willow: Approximately 15.00m. Reduce back to previous reduction points selecting a suitable amount of furnishing growth for retention in order to ensure crown continuity and maintain aesthetic value. Raise crown by 2.00m.

Reasons - General maintenance.
