As you face the front of the drive way to the left hand side corner there is one very big mature Robinia tree, this tree is covered in Ivy. To reduce down all the Ivy on this tree where possible to 6-7 ft high

To cut out any major limbs that have died back or any major dead wood should be cut out of the tree as well

To prune and re-shape the Choisya to the left hand side border

To prune and re-shape the Big Ceanothus to the left hand side border

To prune and re-shape the evergreen Clematis Armandii, and to prune out where possible the dead leaves to the left hand side border

To prune and re-shape the overhanging Ceanothus to the right hand side of the drive way

Following that around to the car post, to prune and re-shape the Ivy and the Clematis to this area

To prune and re-shape the Pyracantha to the left hand side border

To prune and re-shape the Choisya to the left hand side border

To prune and re-shape the Sarcococca to the left hand side border

Walking through the side passage way all the Ivy on the boundary wall all the way through up to the garden shed needs to be pruned and re-shaped again
