T1 is a mature Horse chestnut due to its proximity to the property and the many areas of dysfunction (see hazard report)

Proposed works: Overall crown reduction of 2 metres , reduce large limb overhanging property to give 2metres of clearance.

T2 is a mature silver birch. There is a large area of dysfunction heart wood in the trunk and where the crotch begins limbs have half ripped away and continued to grow and appear to be supported by the adjacent hedge.

Proposed works : Reduce to standing monolith of trunk only .

T3 is a mature Cherry . The long laterals limbs have extended so that the small trunk has many area of adaptive growth to compensate for the strain of the weight of these laterals .

Proposed works : Reduce laterals limbs by 2.5 metres
