					I had already commented on the application 2015/2089/P and those objections were acknowledged.			
					However, since my recent objection on the new planning application does not appear to be on your Planning Portal, I am contacting you (yet again) to note my objection. Rather than restate my objections, I would like it to be noted that in my opinion relevant guidelines and procedures have not been followed in the handling of these applications:			
					1. The first application was allowed to hang over Air for over 8 months – far in excess of guidelines. (16 weeks where an Environmental Impact Assessment is required, from Government Planning Practice Guidelines)			
					2. No clear statement has been made as to whether objections from the first plans will carry forward to the second. Yet the plans are essentially the same.			
					3. The issue of construction noise has been ignored by your building impact assessment. The proposers have not provided an Environmental Impact Assessment or any detailed proposals on how the work could be accomplished at this noise sensitive site. (Air records orchestras from 10am to 9pm – sometimes at a day's notice. Builders make noise whenever they feel like it and vastly underestimate the amount of time required. Ask anyone living next to a basement development.)			
					4. National Planning Policy was not designed to allow one family to close down a thriving business employing many hundreds of people. Local Development Framework Policies are in direct opposition to allowing this application. CPG5 states "7.2 We will protect existing employment sites and premises that meet the needs of businesses and employers". You cannot ignore the disproportional impact of supporting a development at a site for the benefit of one small family which will cause real financial harm to many hundreds, including other local businesses which benefit from the economic activity Air generates.			
					5. Camden Local Plan submission draft 2016 – "5.21 Camden is home to a large proportion of creative and cultural businesses, particularly in the visual and performing arts, music, and video, Im and photography sectors. The Creative and Cultural Industries Research Report and Action Plan 2009 found that these types of businesses create around 40,000 jobs and have an annual gross turnover of about £1 billion in Camden." Air Studios is clearly one of these industries. The document continues: "We will continue to encourage and support the growth of this sector" – by not allowing this project to go ahead.
