**CERTIFICATE OF LAWFULNESS under Permitted Development**

## **RE: 33 BELSIZE LANE, NW3 5AS**

Following our letter issued on 29.01.2016 regarding the Temporary Change of Use from Class A1 (Shops) to B1 (Business) for the above address (Application Ref: 2014/1718/P) which have now expired on 29.02.2016, please find the enclosed application for the Lawful Development Certificate.

As mentioned in our previous letter we have not renewed the permission as we felt this was unnecessary under the changes made to General Permitted Development Order 2015. Under Class D, Change of use of Class A1 (Shops) to Class A2 (Financial and Professional services) is a Permitted Development and with the expiry of the temporary consent the premises is now reverted back to A1 use, allowing it to benefit from a lawful change of use.

XUL Architecture fall under A2 use (Professional services) for following reasons;

- 1. XUL offer services to members of the public in particular in the local area where the potential clients are welcome to 'drop in' without the pre-arranged meetings to discuss their plans with members of our team. In the past 2 years we have been at the current premises, there were 90 'drop in' potential clients recorded. Please see enclosed list for further information.
- 2. Furthermore the majority of XUL's clients and projects are local, within 10 minutes walking distance. Please see enclosed map, U-LP-02 highlighting the recorded potential, past and present projects.
- 3. The definition of 'Professional Services' are "Occupations in the tertiary sector of the economy requiring special training in the arts or sciences. Some **professional services require holding professional licenses** such as

architects, auditors, engineers, doctors and lawyers. Other professional services involve providing specialist business support to businesses of all sizes and in all sectors; this can include tax advice, supporting a company with accounting, or providing management advice."

As highlighted above XUL as architectural practice, we hold professional licenses under Architect Registration Board (ARB), regulating body established by the Parliament in 1997 under the Architects Act. We provide *"specialist business support"* to businesses and private clients which includes Project and Contract managements and advises.

4. The extract below from the Royal Institute of British Architect website suggests the architects' practices qualify as Class A2 use;

"Other permitted development rights to be introduced in April include the conversion of casinos and amusement arcades of up to 150 square metres into homes; **change of use from shops to financial and professional services (which would include architects' practices)**; and change of use from shops and professional services to restaurants and cafes."
