Leyland Cypress T1 - fell to ground level and carry out replacement planting in verge outside number 32 Langbourne Avenue

Reasons:

- 1.This tree has rapidly declined in the last 18 months and is now exhibiting around 40% die back of the crown.
2. The tree is now of low amenity and removal and replacement is now expedient for the future amenity of the site.
3. The decline is likely to be physical in nature (see FC report) due to growing environment on steep bank with road and pavement either side ie. has outgrown it's location
4. The adjoining Leyland Cypress within the line of 6 trees is also starting to show similar symptoms
