As a composer of Hollywood film scores, I am a regular client of Air Studios, which, in my opinion is the finest facility of its kind on the world. The noise and disruption caused by the excavation of the basement - an issue that is not addressed in the revised application - would close the studios for six months, a disruption from which it would not be able to recover. This would be an enormous and possibly fatal blow to the film music recording industry in London. The major multinational film companies that converge on Air from all over the world would have to look elsewhere for somewhere to record, and, with only one other, overly-subscribed studio of comparable size in London still in operation (Abbey Road) they would inevitably take their business overseas.</p> <p>It's impossible to exaggerate the effect noise pollution has on a film music recording session. When 80 or 90 hired musicians perform music that veers from very loud to the extremely quiet, the slightest tap of a hammer can render thousands of pounds worth of work unusable in a second. Air is a 24 hour facility. If it cannot guarantee round-the-clock near silence in its recording rooms, it will be unable to function.</p> <p>I urge you to reject the revised application. I understand there are also major structural concerns regarding the potential damage to the foundations of Lyndhurst Hall, a listed building, with an unmapped underground stream flowing under the building. Air Studios is an international centre of excellence and a jewel in Hampstead's crown. It should be allowed to carry on its valuable business undisturbed.</p>

At a time when we are being told that Government, and by that I assume also Local Government, is committed to British industry (and please remember that the UK Film Industry is a huge employer and exporter) that a proposal that would mean having to close down a key part of that industry is even being considered, surely goes against everything you should be championing.
