I am writing to express my objection to the second planning application by Mr & Mrs Jeffreys of 11 Rosslyn Hill.

I do not live in the borough, but I work as a freelance musician and sing regularly for recording sessions at AIR studios. I think it would be a great shame if the selfish desires of one wealthy family were allowed to impact so heavily on the livelihoods of so many others, given that, were the application granted, the studios would be forced to close for a long period of time. This would have a very negative effect on the earning capacity of AIR studios and on the earning capacity of the many musicians who record music there, not to mention the film and record companies who employ them and who would need to find alternative venues. Last month, Air Studios won the *Music Producers Guild award* for *Studio of the Year*.

I also think the lack of proper consideration for the risk to the neighbouring listed buildings, and the inherent risk due to the underground stream is too great to justify a swimming pool and a cinema for one bounded.

Given that there has been very little amendment to the first application, and given that there have been so many worthy objections to both first and second applications, I would like to see both of them refused.

Dear Mr Tulloch,

I am writing to voice my objections to the following planning applications at 11 Rosslyn Hill, NW3 referenced as  $2015/2089/P\ 2015/2109/L\ and\ 2015/7079/P\ \&\ 2015/7300/L.$ 

I am raising my objections primarily because of the detrimental (perhaps catastrophic) effect any such works will have upon Air Studios, which is an institution which ought to be enshrined in our cultural consciousness - especially on a day such as today when we mourn the passing of Sir George Martin who established these studios.

The notion that a building and enterprise with such a history and continuing cultural prowess should be threatened owing to millionaire neighbours' desire to have a status-symbol luxury basement is appalling in and of itself.

The proposed works should be refused permission as they will affect Air Studios in the following ways:

- 1. As a recording studio it is extremely noise sensitive and if work of this nature and length were to be granted the go ahead it would render the studios inoperable for a long period of time.
- 2. This would not only result in loss of earnings for the company but would affect many musicians and orchestras, film companies etc as there are not enough alternate facilities available in London or the UK.
- 3. The structural risk is serious. The basement, whose construction would devastate the site, is far too big, and would not be acceptable under the Draft Local Plan now out for consultation. There are precedents for Draft Plans to be used in determining applications, especially in relation to listed buildings.
- 4. The Basement Impact Assessment states that damage to adjoining buildings would be no more than Burland Scale 2. This is too much, with unequal listed buildings on each side; one dating from the 18th Century, no doubt of rustic character, the other of late 19th Century, carrying a huge load. We cannot afford to see either damaged in any way.
- 5. Lack of compliance with proper process and also the risk attendant with the underground stream.
- 6. As yet there has been no consultation and no compliance with the Party Wall Act.

I understand that should the proposed works be given permission to proceed, Air Studios would have to cease its operations for 6-12 months, and possibly never reopen.

There is also a traffic risk, risk to 2 listed buildings, an underground water risk and the taking of such unquantified risks is not appropriate in this instance.

Dear Sir or Madam,

I wish to object to and protest against the application as listed in my subject header. As a local resident of some years, and someone who works in music and media, I am only too aware of the importance both to my local community, and to my professional community, of Air Studios.

Air is a world-class recording and production facility, renowned not just for the talented people who work there, but for the special and unique nature of the recording studios built in the Lyndhurst Road building, whose sonic properties are highly sought after. Nevertheless, the severe risks as I understand it, of Air's business being impaired or suspended as a result of the work called for in the application, could, I suggest, be hugely damaging, not just to Air's business, but on a far wider level.

Firstly, in terms of the benefits that Air's success brings to local businesses, shops, restaurants, services and so on here in Hampstead and Belsize Park, not to mention the creative and artistic ventures supported by the studios.

Secondly, in terms of Air's vital role, directly and indirectly, in employing hundreds of musicians, technicians, organisers, and support staff.

Thirdly, in terms of the symbiotic relationship between Air and the other main studio venues in London is feasible as a recording venue for major motion pictures and TV shows because Air and Abbey Road, in particular, are able to act as overflows for each other's projects - so when one studio is busy with one project, the other can take another project on, with projects often moving between one venue and the other in the course of a long production schedule. If London's studio capacity is suddenly reduced, it will become far more difficult for major projects to make their home here with the result that they will seek to record in mainland Europe. Once this work has left the UK, it will be a challenge to bring it back.

Finally, in terms of the risk to two listed buildings; the risk in terms of underground water; and that the taking of unquantified risk is not appropriate in this case.

For all these reasons, I object most strongly to the application.
