Previously reduced Black Poplar

As you face the tree from garden of 33a Dartmouth Park Avenue, the left hand side of the crown was not reduced to form a balanced symmetrical crown.

We advise the following :

- Reduce entangled limbs as shown as A + B, back to the main knuckle of the limb leaving secondary growth approx 3-4 metres then reshape this side to form a more balanced canopy.
- Reduce the limb marked C back to main knuckle (this limb overhangs the garden of 33a Dartmouth Park Avenue)
