The plans should have been posted so all residents can see them upfront, rather than have to search through the documents online.</p> <p>The cameras on poles are hideous. They will make the estate look like a prison block, or urban ghetto. I particularly object to the camera proposed for the hill. There has been no antisocial behaviour down on this level for many months, and I would call the police if any were to start. In fact since moving here over 12 years ago, I have found the past year to be the best so far in terms of problem behaviour.
