his notification can be used by a household to notify a local planning authority of the intention to use the permitted development rights o build a single-storey rear extension of greater than four metres up to eight metres for a detached house and greater than three metres up to six metres for any other type of house outside Article 2(3) land\* and sites of special scientific interest.
