## Proposed Work:

REAR GARDEN: 2 x Sycamore (T1 & T2) - crown reduction to previous pruning points (approx 4m crown reduction), remove lowest branch over garden on left, removal of dead branches:

- 1 x Lime (T3) crown reduction to previous pruning points (approx 4m crown reduction), lift to 6m, removal of dead branches;
- 2 x Sycamore (T4 & T5) crown reduction to previous pruning points (approx 4m crown reduction), lift to 6m, removal of dead branches;
- 1 x Horse Chestnut (T7) crown reduction to previous pruning points (approx 4m crown reduction), lift to 6m, removal of dead branches;
- 1 x Sycamore (T8) crown reduction to previous pruning points (approx 4m crown reduction), remove lowest branch over garden on left & right, removal of dead branches;
- 1 x Maple (T9) crown reduction to previous pruning points (approx 4m crown reduction), lift to 6m, removal of dead branches;
- 1 x Sycamore (T10) crown reduction to previous pruning points (approx 4m crown reduction), remove lowest branch on left, removal of dead branches.

The Council has considered your notification of intended works to trees dated 16 February 2016 and does not wish to object.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
