1- Tree Of Heaven (x1) Fell to ground level. Reasons: The roots of the tree have pushed over the boundary wall of No.26 Winchester Road and are also damaging the wall of No.28 Winchester Road. The tree itself is very likely self-seeded. Tree of Heavens are extremely fast growing trees which can reach 100ft. If it is retained it is likely to cause further problems in the future.
