T1 plum (neighbours): reduce overhanging branches by up to 2.5 metres

Blocking light into house, branches touching property and causing an obstruction over the terrace.

T2 cherry (neighbours): reduce branches overhanging garden by up to 3 metres

Blocking light, shading lawn, branches have been cut back on neighbors side and tree is now heavily unbalanced.

T3 sycamore (neighbours): reduce large limb growing over garden to a pollard point 3 metres from the main stem. Reduce remainder of laterals by up to 2 metres to blend in with canopy.

Blocking light to property, shading lawn tree has not been reduced for a number of years and is also suppressing growth to the shrubs.
