Such change ignores the local Neighbourhood Development Plan which was passed at a referendum in July 2015. Furthermore, it would impact on the value of the property which would make it harder for People's Centre to eventually buy and continue to develop it as a much needed community resource for people with disabilities and the wider neighbourhood. The Design and Access statement fails to mention People's Centre for Change, a not for profit voluntary organisation also using the building, or to consider the impact of such a change on its membership and activities, current and future. The Design and Access statement also states that the current day centre provision will be re-provided in a Greenwood Place. I believe that the provision in the new centre will not be sufficient to support the current and growing numbers of people with high support needs and that it fails to properly assess the impact the lack of day centre/opportunities on this group, and that Camden fails its duties under the Care Act to provide for choice, market development and inclusion. (Signed by 424 people: see below) WHY IS IT IMPORTANT Why is this important? PEOPLE SAID "a community resource not luxury flats": after a petition, an Independent Inquiry and a local referendum (July 2015) 96-98 Shoot up Hill was listed as one of the community facilities to be protected from any change, in the Fortune Green and West Hampstead Neighbourhood Development Plan. ( At the hearing Camden''s Assistant Director of Adult Social Care and a planning officer presented Camden''s arguments against listing of 96-98 Shoot up Hill as a community facility, with reference to Greenwood Centre. People''s Centre for Change argued the case for listing as community facility and the need to recognise the nature and needs of t

and which give them a sense of belonging.

Some people also need the continuity and familiarity of a vibrant and inclusive community where they they are understood, fully accepted and welcomed and can choose from adapted and suitably challenging activities, and develop relationships with all sorts of people.

PEOPLE"S CENTRE = AN ALTERNATIVE: a group of people with learning disabilities, family carers and advocates campaigned against the closure and in April 2012 the council agreed to delay the closure and give them time to develop their proposals and raise money to buy the building. Cabinet also promised not to close or sell the building at 96-98 Shoot up Hill until the new Greenwood Centre was built. People"s Centre was then set up as a not for profit organisation to fill in a gap in provision and offer an alternative to a traditional day centre, taking advantage of personalisation providing: excellent individually tailored choices of activities, learning opportunities, social and training/employment opportunities and support to people with a wide range of learning disabilities in a friendly, INCLUSIVE environment as well as new opportunities for the wider neighbourhood; modelling successful inclusion and supporting people to access other community venues.

NOT BACK TO INSTITUTIONS!: the council recognises the need for "building based" services but want to build a single, purpose built, large institutional facility (Greenwood Place) grouping people with all manner of impairments in discrete units: learning disabilities, mental health, dementia, autism, multiple and profound learning disabilities. People will be segregated according to what they cannot do (medical model), as well as set apart from the neighbourhood (in a back street, semi industrial area). Moreover Greenwood Place also lacks capacity to provide facilities for the current and growing numbers of people with high support needs. Extensive consultation results failed to record the many objections the various groups made to this project and associated day centre closures and EIAs failed to recognise important protected characteristics.

SMALL SCALE, INCLUSIVE, COMMUNITY RESOURCES, INSTEAD: People's Centre is developing a friendly and welcoming community place where people of all abilities and backgrounds complement each other, can get the support they need and engage in meaningful activities as well as go out to other places. We will model good practice.

BUILDINGS AT 96-98 Shoot up Hill ARE IDEAL: two semi detached houses which front a main road, look just like the neighbouring houses and allow for flexible use. They been adapted with accessible lift, WC facilities, changing room etc. There are no equivalent premises in the area and the cost of providing such facilities in another building will be prohibitive as well as wasteful. The building offers capacity to develop a growing inclusive community

People"s Centre argued at a deputation to the council in January 2014 that the council would not need to sell the building at 96-98 Shoot up hill to develop the Greenwood Place, given the increase in property prices and asked the council to look at their business case again. The council have not provided new figures.

The building at Shoot up Hill which the council wanted to sell in September 2012 was valued, for the April cabinet meeting papers, together with the day centre building in Raglan Street, Kentish Town, at a combined £2.2million (assume £1.1million for business case for Greenwood). The money from sale of Shoot up Hill is linked to the building of Greenwood in Camden"s CIP.

Camden have changed the original plan and have negotiated a deal with AA storage. A complete and transparent business case has not been made public.

PEOPLE"S CENTRE = AN ALTERNATIVE: a group of family carers campaigned against the closure and in April 2012 the council agreed to delay the closure and give them time to develop their proposals and raise money to buy the building. People"s Centre was then set up as a not for profit organisation to fill in a gap in provision and offer an alternative to a traditional day centre, taking advantage of personalisation: excellent individually tailored choices of activities, social and employment opportunities and support to people with a wide range of learning disabilities in a friendly, INCLUSIVE environment as well as new opportunities for the wider neighbourhood; modelling successful inclusion and supporting people to access other community venues.

NOT BACK TO INSTITUTIONS!: the council recognises the need for "building based" services but want to build a single, purpose built, large institutional facility (Greenwood Place) grouping people with all manner of impairments in discrete units: learning disabilities, mental health, dementia, autism, multiple and profound learning disabilities. People will be segregated according to what they cannot do, as well as set apart from the neighbourhood (in a back street, semi industrial area). Moreover Greenwood Place also lacks capacity to provide facilities for the current and growing numbers of people with high support needs.

SMALL SCALE, INCLUSIVE, COMMUNITY RESOURCES, INSTEAD: People's Centre is developing a friendly and welcoming community place where people of all abilities and backgrounds complement each other, can get the support they need and engage in meaningful activities as well as go out to other places. We will model good practice.

BUILDINGS AT 96-98 Shoot up Hill ARE IDEAL: two semi detached houses which front a main road, look just like the neighbouring houses and allow for flexible use. They been adapted with accessible lift, WC facilities, changing room etc. There are no equivalent premises in the area and the cost of providing such facilities in another building will be prohibitive as well as wasteful.

#### WHAT WE ARE DOING NOW, outside day centre hours and weekends:

- Weekly creative, social and therapeutic sessions for adults and young people with learning disabilities supported by volunteers, family and support workers. Open to everyone in the neighbourhood. Cafe with freshly cooked delicious food.
- a "Unique Products" enterprise where people with and without disabilities work together.
- weekly sessions and special events for unpaid carers in Camden
- Saturday Stay and Play for families with children with disabilities, siblings and friends.
- (soon) Weekend specialist yoga to families with a member with disabilities.
- Open Days, Special Concerts, Carers Week Day and Community Festivals bringing together people of all ages, backgrounds and abilities to make music, art and enjoy life.

					The small number of stated residential units to be acquired through the proposed change of use is a long way removed from sufficient justification to consider destroying this well-established, well-used, much-loved community asset. The services provided by the People's Centre for Change enrich and improve the lives of exponentially more people than would six additional housing units. The People's Centre for Change has ensured that the buildings have been fully adapted to meet the needs of its service users and so the spaces are ideally suited to the purposes for which they are used.
					The true value of the buildings are in its existing D1 incarnation and in its occupants and the sum total of the real value of those factors is far in excess than that of any arbitrary property value. Furthermore this value is provided to a great and growing number of people with support needs for whom needs are better met locally and in familiar surroundings than, for example, in some geographically remote alternative proposed by the council. That the People's Centre for Change has continued to grow and thrive over the years and has built a large community around its service provision is testament to its true value on which a price in pounds sterling cannot be put.
					The building and facilities are "widely used, appreciated" and "support the community's needs" and should be "supported and their site protected" under policy E7 Public and Community Facilities of the Neighbourhood Development Plan, notwithstanding the NDP"s inbuilt get-out clause which states, "unless a replacement facility is provided". As outlined above, a geographically remote alternative would destroy the existing services and community and simultaneously would fail to meet the needs of its many vulnerable service users.
