Prune T4 Hawthorne located at the neighbouring garden according to the following specifications: Reduce crown height and spread by approximately 2-3 metres to enhance natural form.

Prune T5 Laurel group located at the neighbouring garden according to the following specifications:

Reduce crown height by approximately 5-6 metres to provide clearance to garden.

Prune T6 Bay located at the left side of property rear garden according to the following specifications. Trim to maintain desired shape.

Prune T7 Yew located at the left side of property rear garden according to the following specifications:

Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.

Reduce crown height by approximately 2-3 metres to provide clearance to garden.

Prune the following property items:

T8 Goat willow located at the back of property.

T9 Willow located at the back of property. according to the following specifications.

Reduce crown height by approx. 5-6 metres to provide clearance to garden.

Prune SH10 Pyracantha located at the right side of property rear garden according to the following specifications.

Renovate shrub by removing approximately 50% of stems. Prune remaining stems as necessary with the objective to reduce size and enhance natural or desired form.

Prune T11 magnolia located at the right side of property rear garden according to the following specifications: Reduce crown height by approximately 1- 1.5 metres to provide clearance to garden.
