And in the end, that is why architecture can be considered the most democratic of art forms.</p> <p>Kings Cross is a magnificent example of mid Victorian architecture but it was built to serve a purpose as a rail terminus. The open space in front of the building would have been a bustling hub of activity, with horse drawn carts, people gathering and goods being loaded and unloaded. If we look at the design of the building, it could be argued, therefore, that the magnificent glass arches were designed to be seen above all this activity. That the smaller arches were less pleasing and functional rather than dramatic or splendid. The new design of the building with its wonderful square re-visits the open plan feel of the original design. In keeping with the original purpose of the building this area should be a bustling hive of activity and a focal point for the local community.</p> <p>A market in the Square, therefore, does not detract from the Cubitt's server design but instead celebrates its original intention. A vibrant terminus for trains and the people who use them.</p> <p>Market squares for hundreds of years have been the focal point of local communities with markets, activities and entertainments. Not ensuring that this space is used to its full and provide a focal point that would encourage engagement with the local community would be an act of neglect and create a dead space. Surely for Cubitt's magnificent station to be admired and appreciated people should be encouraged to linger, enjoy the piazza. The energy and atmosphere generated by the market compliment and augment what is fast becoming one of London's most vibrant districts. Having traded at Borough Market for many years it has often struck me how an area can be transformed for the good where a major rail station meets a quality food market. The dynamism now found at and around the Borough Market, near London Bridge station, would have been unthinkable fifteen years ago. This energy and vitality can be reproduced at King's Cross if the Real Food Market is given the go-ahead to return.</p> <p>We are a small cheesemongers concentrating on the sale of just four cheeses. Initially, we only sold one: Comte, a French mountain cheese. To base a business around a small platform of products means we need to select the best cheese we possible can. To this end we travel to France every five to six weeks to choose the cheese we sell back in London. To highlight what we do and emphasise difference our efforts make in a highly competitive market we need to concentrate on training our staff. This takes time and effort. Since the market at King's Cross has been suspended we have resisted the temptation to lay people off. Rather, we have redeployed them to other markets we trade in the hope that the King's Cross market will be reinstated. I sincerely hope this is the case otherwise we will have to lay off staff we have invested much time and care.</p> <p>It seems extraordinary to me, given the immensely positive feedback from all the customers i spoke to over our time at the market, that a food market such as this could be seen to somehow detract from the are.
