Fraxinus excelsior(?) located in the SW corner of the garden, directly abutting the boundary wall. The tree is in close proximity to another of the same species and I propose to fell in order to allow this second tree to thrive without crowding and also to prevent damage to the boundary wall in the future. A suitable British native tree will be planted as a replacement at a more appropriate distance from the boundary within the same garden. Due to current concerns about Ash an alternative genus will be selected.
