Thanks for the information you sent me. I have the following comments.

My comments on Section 5 - Design

The proposal will be accommodated within the existing roof form. It is stated that roof extensions and even additional storeys are acceptable where there is an established form of roof, which there is along Chalcot Road. Our proposal is architecturally sympathetic to the terrace and follows good design practices. Additionally it is not out of scale.

Primrose Hill Conservation Area Statement

More specifically referring to the Primrose Hill conservation area statement (page 31) and paragraph PH18 the proposal is not detrimental to the terrace, in fact a neighbour has implemented an almost identical scheme. Referring specifically to the paragraph PH19, which you referred me to, states the road and house numbers where roof extensions will not be permitted, 11 Chalcot Road is <u>not</u> on the list.
