Mr Whittingham confirmed to Philip Everett from the City of London that he thought the Council would be unlikely to require the sedum roof in this situation but they would like to see whatever finish we propose for the roof. It was also understood that rainwater harvesting may not be appropriate in this situation but further information was requested (included in covering letter).

Proposed engineering works to the Hampstead and Highgate chains of ponds comprising dam raising at Model Boating Pond (2.5m) and Mixed Bathing Pond (1m), new walls along dam crest to increase the height of the dams at Men's Bathing Pond (1m) and Highgate No.1 Pond (1.25m), a 0.19m kerb along the part of the crest at Hampstead No.2 Pond, a new flood storage dam (5.6m) in the catchpit area, grass-lined spillways at most ponds, dam crest restoration, pond enlargement at Model Boating Pond, a replacement changing room building at Ladies Bathing Pond and associated landscaping, habitat creation and de-silting.
