


		Regents Canal CAAC, Kings Cross CAAC and the Kings Cross Development Forum were consulted however, no responses have been received.						
CAAC/Local groups comments:	Canals and River Trust: We have no objection to the proposed design of the wayfinding signs and agree with the positioning of most of them. However, we are concerned about the positioning of No.14. This is very close to the boundary with the towpath, which is narrow in this area. The landscaping works around the Gasholder Park will help to widen this shared space, and it would therefore be unfortunate to restrict it again with a large sign. The bridge creates a narrowing of the path, as well as the towpath edge, where there is an historic inlet detail in this location. The towpath is							

increasingly busy in this area, with cyclists and pedestrians, and we are keen that as much width as possible is created and that pinch points are limited. We would therefore suggest that this sign should be set back further from the water's edge, and be set behind the line of the adjacent building and Gasholder structure.

Officer response: Revised plans have since been submitted showing sign 14 set further back from the towpath which will ease the flow of pedestrians and cyclists in this area.

Site Description

The proposed signs will be installed at strategic locations across the entirety of the Kings Cross Central site with some located within the Regents Canal and Kings Cross Conservation Area.

Assessment

1.0 PROPOSAL

1.1 Planning permission and advertisement consent is sought for the installation of 18 bespoke wayfinding signs across Kings Cross Central (KXC) which will include more detailed information about the various destinations at the site. The proposed A-Frame totem signs will present a map with directional information on one side, similar to the Legible London midi/minilths, and a "What's On" panel on the other which will include advertisements and information on the current events happening around (KXC). The proposed signs would have a height of 2.6m, a width of 0.6m and a base depth of 0.55m. During the evening the signs will be internally lit by LED lights and an in-ground luminaire to ensure maximum legibility.

Revisions

1.2 The Canals & River Trust raised concerns regarding the position of sign 14 and the potential restriction it would have on pedestrian and cyclist movement along the canal towpath. To address this issue the sign has now been re-positioned further away from the water's edge ensuring access along the towpath remains unrestricted.

2.0 ASSESSMENT

- 2.1 The material considerations for this application are summarised as follows:
 - Design and Conservation; and
 - Amenity of neighbouring residential occupants;

2.2 Design and Conservation

- 2.2.1 The Council's design policies are aimed at achieving the highest standard of design in all developments. The following considerations contained within policy DP24 are relevant to the application: development should consider the character, setting, context and the form and scale of neighbouring buildings, and the quality of materials to be used. Policy DP25 'Conserving Camden's Heritage' states that within conservation areas, the Council will only grant permission for development that 'preserves and enhances' its established character and appearance.
- 2.2.2 The proposed Kings Cross wayfinder signs have been designed in coordination with the TfL Legible London system with six Legible London signs to be located around the periphery of the site, which will be applied for as part of a separate application.
- 2.2.3 In order to integrate with the surrounding area the proposed Kings Cross signs share a similar size, scale and format as the Legible London signs. The proposed height of 2.6m would match the height of the Legible London *minilith* & *midilith* totems, which are prevalent throughout the Central London Area, ensuring that the new signs follow an established format and do not have an overbearing impact on the character and appearance of the surrounding area.
- 2.2.4 Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the conservation area, under s.72 of the Planning (Listed Buildings and

Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013. The bronze and turquoise colour scheme proposed would give the signs a stylish and contemporary aesthetic whilst paying tribute to the industrial heritage of the site and would not harm the character and appearance of the surrounding conservation areas.

- 2.3 <u>Impact on amenity of neighbouring residents and public safety</u>
- 2.3.1 The proposed signs will be lit internally through LED lights fixed to the back of the information panels and an in-ground luminaire at the base of the sign. This base light would discharge a beam of light at a 45 degree angle on to the inner surface of the totem which will reduce the amount of glare and light spillage emanating from the signs for both neighbouring residents, and passers by. There would be no other implications on the amenity of present or future residents at the site as a result of the development
- 2.3.2 The locations of the new signs are considered acceptable from a highways perspective and would not have a harmful impact to either pedestrian or vehicular safety in the area.

Conditions and Reasons:

1 No advertisement is to be displayed without the permission of the owner of the site or any other person with an interest in the site entitled to grant permission.

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.



- 2 No advertisement shall be sited or displayed so as to
 - (a) endanger persons using any highway, railway, waterway, dock, harbour or aerodrome (civil or military);
 - (b) obscure, or hinder the ready interpretation of any traffic sign, railway signal or aid to navigation by water or air; or
 - (c) hinder the operation of any device used for the purpose of security or surveillance or for measuring the speed of any vehicle

3 Any advertisement displayed and any site used for the display of advertisements, shall be maintained in a condition that does not impair the visual amenity of the site.

4 Any structure or hoarding erected or used principally for the purpose of displaying advertisements shall be maintained in a safe condition.

Where an advertisement is required under these Regulations to be removed, the site shall be left in a condition that does not endanger the public or impair visual amenity.
