NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

REAR GARDEN: 5 x Limes - reduce crowns by 30%, reduce overhanging branches by 30-40%, remove ivy from within crowns of the trees and from the main stem to a height of approximately 8.00m

1 x Laurel large, single-stemmed T1 - reduce crown by 25% and thin crown density by 20%.

1 x Hawthorn small T2 - reduce and thin by 20%

Laurel Group - reduce collective crown by 25%.

1 x Holly T3 - reduce crown by approximately 20%.

1 x Ash twin-stemmed (approx. 19m) T4 - reduce back to previous reduction points

1 x Holly T5 - reduce extraneous growth back into main crown structure, approximately 25% to promote a more compact form.

1 x Cherry (approx. 16m) T6 - reduce crown by 25-30% and thin crown density by 20%.

1 x Holly (approx. 4.50m) T7 - reduce crown by 20%.

1 x Holly (approx. 9.00m) T8 - reduce height by approximately 40% and re-shape to balance and promote a more compact form.

1 x Hawthorn T9 - reduce crown by 20% and thin crown density by 20%.




The Council has considered your notification of intended works to trees dated 20 February 2016 and does not wish to object.
