Whilst, like B.W. Collins, I wholly support the regeneration of King's Cross Square, I find his objections to the market absurd on several levels. Firstly, by characterising the market as 'clutter' he draws a particularly bizarre comparison with the 'African Village'. The latter was indeed a large, unsightly conglomeration of architecturally insignificant buildings which detracted from Cubitt's station facade. Thankfully, the King's Cross regeneration project has seen their demolition. The Real Food Market, however, is confined to a tiny portion of the square, and consists of a small number of colourful, pop-up structures around 2 meters high. The stalls are uniform and aesthetically inoffensive, whilst the produce they shelter is artistically arranged. Not only do the stalls add a certain vibrancy to an otherwise rather dull square, but they are only in place for four days per week. Rather than detracting from the original station design, they add charm and character - as another poster has commented, the square would have originally been a local hive of activity where market vendors would have been welcomed. Furthermore, I fail to see how the instigation of a small-scale market selling high quality produce would detract in any way from the creation of a 'high quality public realm.' The market attracts a vast number of tourists, locals, and commuters, whilst each stall has obtained a following of regular customers. Indeed, having become very well-known, the market has helped to create a cultural hub in an area which, ten years ago, was a locus of crime. The restoration of the market will only serve to brighten the area, and to reject this planning proposal on the basis of a single objection based on personal bias would be outrageous.
