When I viewed this flat, I was informed that other flats might be available soon, however I chose this flat because I have a lot of illnesses such as tinnitus which drives me crazy, and I chose this flat because it's quiet, the balcony is facing away from other flats and also because I am a sky watcher for which I have a telescope. This hobby helps me to ignore the tinnitus as well as my other illnesses.</p> <p>With the plans that have been submitted, the developer is proposing to build a two storey building right outside of my sitting room and bedroom windows. This will obstruct my views of the sky, it will diminish the amount of sun light I currently have. It'll will affect my already fragile mental health due to severe anxiety and depression (my GP and consultant can confirm this). Furthermore, I depend on free flowing fresh air due to COPD and often have my windows open so that I can catch my breath. Building in front of my flat will impact negatively on my health both physically and mentally and I object to the proposals. I want to strongly object and if this plan is accepted I will be taking the actions of a legal route and will have to let a judge decide and I have free legal aid.</p> <p>When I viewed this flat, I was made aware of the impending sale of the 6 garages and I accepted this as it wasn't right in front of my flat. However, now I understand the 2 remaining garages have been sold to the developer and I object strongly that my views and privacy is going to be affected. If this goes ahead my views from my windows will be blocked and I'll be looking directly at the brick wall/windows/back of the new building.</p> <p>It is a nightmare for me to carry my shopping from the lift in the building to my flat, however despite there being a different flat available at the time I was viewing, I specifically chose this flat because of the privacy and the views it gave me. From a life with 100% quality I have just 10% left and I don't want to let anyone take that away from me. I stopped smoking and since I heard that this development may happen I am so stressed and angry/furious that I am so tempted to restart smoking again! I have been told that the building works might happen and the noise might be difficult to deal with. This I could accept but I cannot accept that the building proposal that's before you now.</p>

I strongly object to this proposal for the following reasons.

1. The proposal would have a huge and unacceptable impact on the normal level of amenities that I expect and require for my home, which is the nearest property to the proposal and having the shortest rear garden of any of the adjoining houses.
2. Notwithstanding the study which has been carried out on behalf of the applicant, the four story proposal would have an overbearing effect on the habitable rooms of my home and upon my small rear garden.
3. The four story proposal is out of character with the street scene and the established character of the immediate vicinity.
4. Notwithstanding that obscured glazing has been specified, the flank windows of the proposal would create a sense of overlooking and an unacceptable sense of invasion of my privacy.
5. The removal of the access to the garages and parking spaces has already had an effect on the parking in the area. Visitors to the proposal would add to the current problem. I have already had cars parked on my driveway without my permission and it is causing me problems.

If this application is to be heard before a committee i register my wish to speak at the hearing and put my objections directly to the committee.
