Details of the pre-application advice received:

"A rear extension would appear possible in this location but the impact upon the adjoining neighbouring No. 2 would need to be reduced. The side element of the proposed extension would create difficulties in both creating an incongruous wraparound extension at odds with the character of the host dwelling and infilling an established gap in the built form in terms of the design of the wider urban form. At the very least, it is suggested breaking up the side and rear elements and reducing the width of the side element.
The proposed first floor roof terrace is not in keeping with the surrounding area and would create additional overlooking and privacy concerns. Screening may be possible but that screening may also create adverse effects on the appearance of the proposed extension. The conversion of the garage into habitable accommodation is possible supposing that this conversion would not result in additional on street parking and the alterations to the garage door would maintain the existing ground floor façade along the terrace."

All of the above comments have been addressed in the current design.
