### Shroud:

The proposed temporary shroud will be installed solely upon the front elevation of the site fronting Euston Road and not wrap around either of the corners of the building.

The entire building is to be scaffolded to allow the proposed redevelopment of this building to take place, the required programme of works that confirms this is attached to this correspondence. As can be ascertained the scaffold is essential for the works to be undertaken, and without a scaffold the proposed refurbishment of this building cannot be completed. (Location plan and OS amended as requested are now attached)

We trust that the supplied document detailing the scope and extent of works confirms this fact, and this particular point can now be agreed?

### Externally Illuminated Advertisement:

We have noted your comments upon the size and illumination of this proposed display, but as previously stated in our planning report we contend that the requested size of the commercial banner ( 45m x 20m = 900 sqm) is appropriate for the size and scale of the scaffolding and the host building. The proposed banner is clearly in scale with the enormity of the Camden Annexe and will not look out of place or as uncertain or inappropriate feature upon the scaffolding.

Your reference to Camden Planning Guidance (CPG1) Design has been noted- but we are sure that you will accept that Council Guidelines <u>can- not be decisive</u> and are just that -only "guidelines" as has been demonstrated recently in similar appeal decisions.

Turning now to the proposed illumination of the banner, our proposal only requests that the commercial display be illuminated when a commercial banner is in position. Furthermore, the banner lights would only come on at dusk and would be programmed to extinguish themselves at 11pm. In addition the proposed lighting has a luminance level of less than the 600cdm limit as requested by planning guidelines for the illumination of adverts.

The proposed banner lights would be positioned to solely illuminate the commercial banner, and are designed and installed with lighting shields so that only the banner is illuminated and that light pollution is prevented. The lights are highly energy efficient and are the most environmentally friendly available.

Indeed, it is our assertion that the proposed banner illumination <u>will not</u> cause a detrimental effect to the amenity of the surrounding area, which is clearly a highly illuminated city centre location.

Mention has been made of the previously consented banner display that was held by Camden Planning Team to be in order in 2012 (under planning reference 2011/5760/A). This proposal awarded temporary consent for a banner advert display of 1560 square metres to be shown upon the very same building-Camden Town Hall Annexe, that we are now requesting a similar consent for.

It was held that this larger banner was not a detriment to either the Amenity or Public Safety of the site or the locale. As our current planning application (2015/5487/NEW) requests permission for a smaller Temporary banner display in a similar position on the building, and as suggested previously is " on all fours" to the earlier approved banner display we would assert that a similar view must be taken upon our new application.

The content of any proposed banner display or message can- not have any bearing upon a planning application to display adverts, and therefore your suggestion that the Olympics banner was " not approved for commercial purposes" cannot be used as an argument or defence as not to approve this current application. Thank you for your response.

Unfortunately, my position on the proposal in its current form, along with the information provided, cannot be altered. The proposal is unacceptable on the reasons already given in my previous email.

The shroud and advert approved for the Olympic was only granted advert consent for a period of 4 months. It was seen as part of the Look and Feel designs the Council had allowed elsewhere on smaller lamp post designs. Also, the decision did specify that:

"Although its purpose is not to shield construction work, the guidance's resistance to advertising is that adverts on such large prominent sites can harm the amenity of an area, but the content of the proposal, celebrating a once in a lifetime event such as the Olympics, should not be seen in the same light as a purely commercial advertising site.

The application must also be seen in conjunction with the city wide celebration of the games which will include colour and planting schemes, bunting, banners, flags and bespoke items using the London 2012 'Look' and 'Feel' design guidelines which have been created to help celebrate the Olympic and Paralympic Games coming to the UK."

It must also be noted that the proposal was never implemented.

The Council's position in relation to your proposal is to refuse it as submitted. Any approval will be considered based on the amendments recommended in my original email dated 30<sup>th</sup> September. Policies are in place to provide guidance when assessing any given proposal and are to be followed, adhered to and implemented by applicants/agents and the Council. They are not to be ignored or over looked.

You must therefore amend and submit the following:

- Works Schedule Statement detailing the various stages of the construction works to support the need for a shroud to be erected on the chosen elevation;
- The relevant drawings according to the above recommendations to be amended ensuring to annotate revision references;
- Annotate all drawings with a drawing reference;
- Confirmation in writing for the removal of some of the information originally submitted which would no longer be relevant such as the "lighting details" fact sheet;
- The "banner fixing banner" drawing to be amended by removing the lighting details [ensure to annotate a drawing reference as well as a revision reference];
- Your application supporting statement to be amended by removing any reference to the method of illumination;
- Section 7 and 11 of your application form to be amended by adding the shroud and its measurements;
- The method of illumination of the signage to be amended from externally illuminated to non-illuminated;
- The "Typical Banner System" drawing shows what is either a section through the scaffolding or a side elevation in context with the a building that does not represent the Former Town Hall Extension and can therefore not be accepted as a supporting document to be approved. Please submit a section drawing or side elevation demonstrating the work area between the scaffolding and the accurate building. You will also need to remove any annotations and references to the lighting. [ensure to annotate a drawing reference as well as a revision reference];
- The red line demarking the site boundaries needs to extend so to include the area of erection of the scaffolding on both the OS Map and the Site Plan. Both drawings also have identical drawing reference to be amended accordingly [ensure to annotate an individual reference number and a revision reference]
- Photo Montage if possible but not compulsory.

Unless the above items are provided, your application, as it stands, is to be refused.




