We believe all points previously raised with you about redevelopment of this site still stand and would ask that they be carefully considered with regard to the appeal from the developer that you recently received but as yet have still not made public/posted online. In fact all points raised around noise pollution and lack of concern about disturbance caused by noise made by builders/contractors have unfortunately been proven over the last fortnight. With asbestos removal taken place over a weekend, and skip delivery/collection taking place before 7.00am. As well as the vehicle that collects the skip on one occasion scraping along the side of house number 1 mid afternoon on Wednesday 6th April.

We are concerned that the **integrated gardens/warehouse walls are currently being made vulnerable** by constant use of heavy demolition drill daily. Two week solid now, at least 10 full industrial skips full of brickwork.

We would like to know is this part of our garden wall part of our homes GRADE 11 listing, as we have been led to believe it is

We are concerned that address **1A** is used on the warehouse site and at house number 1 in Highgate Road and would like Camden to research the **Curtilage** (legal concept which applies to land as well as to the buildings on the land) of Houses number 1/3 Highgate Road, as both have GRADE11 listings

We would like to know why the Planning Department is sitting on this formal Application received alongside a formal an appeal against a refusal decision, sometime during the week ending 1st April when they should be notifying all concerned local residents for their comments.

We look forward to your prompt response.




