At the bottom of the garden to 25 Lancaster Grove there is an existing concrete air raid shelter covered with earth. To the right of the air raid shelter a tree has self seeded on top of the shelter. The shelter is required to be removed together with all earth coverings to enable further garden space for the enjoyment of the dwelling. The tree roots spread on top of the concrete roof to the shelter and as the shelter has got to be removed these roots will be exposed leaving the tree in a dangerous state. We request that the tree be removed on grounds of safety and that a replacement is incorporated in the garden and in conjunction with the landscaping scheme which has to be submitted prior to the apartment coming into occupation.
