Each of these planning applications have an average of 20 to 30 and several of these Planning Applications have over 60 large drawings that can not be viewed on a standard computer screen and require considerable computer skills to manipulate. Even on a 32inch screen there are far from easy to view.

Most of the residents who are supposed to comment on the proposals do not have that much experience to view the drawings and or reading all the technical details. The Camden Redevelopment Team are extremely unhelpful and while the contractors Durkins are a little more helpful they do not have the time or the real willingness to explain or to discuss.

The other problem is that Durkins are not equipped to pass on the comments of residents regarding the project. Quite apart from the fact that Durkins Site office working hours are 9am to 5pm except Friday when the FFF situation applies.

Councillor Fulbrook and Camden Redevelopment Management team claim to be consulting with the residents each month. In fact this is untrue as the meetings are dominated by Councillor Fulbrook, standing up and giving a speech telling the few that attend these meetings as little as possible about the project its self but how far much they have achieved. There is no discussion of detail or of the design.

The so called Liaison Meetings are much the same. There is no scrutiny of proposals and no meaningful discussion or examination by the residents.

Councillors Fulbrook and Councillor Olad have successfully manipulated the one person who could hold Camden Redevelopment team, to account and possibly get a design that will not have to be modified at substantial cost and considerable inconvenience to Camden Council and to the Residents in the future after the building is completed. To be banned from attending the meetings. This ban is designed to enable Councillor Fulbrook to get his Swansong Monument Project into reality before he retires.

The residents of Windmill Residents Association join with the Residents of Tybolds Estate and the surrounding streets Orde Hall, Harpur Mews Dombey Street, Lams Conduit Street, and Great Ormond Street to name but a few of the streets who's residents and business's who will be effected by this major redevelopment that have not been properly consulted.

It is contrary to natural justices for so many who are effected not to have a proper opportunity to see and comment on the large number of amendments that have been proposed. Quite apart from the fact that the Ward Councillors who are forcing the redevelopment project. Have a vested interest in a quick completion.

We the residents of Windmill, Blumnsbury, Richbell, Springwater, Falcon, Babington, Chancellors Harpur Mews Orde Hall Street and Dombey Street and many other residents demand that Camden Council Redevelopment Team and their Contractors hold a full open Drop in Consultation where the residents can see all the drawings and the detailed plan. As well as the proposed working arrangements. Regarding Excavation Muck Away and are made fully aware of the level of disruption that Camden Council is about to impose on the residents of Holborn.

At Councillor Fulbrook's meeting of the 15<sup>th</sup> March 2016 it was claimed by Camden Redevelopment team including Councillor Fulbrook 18 persons attended. From the information I recived only 6 residents attended. The meeting on 19<sup>th</sup> April 2016 only 4 residents attended. This in not due to lack of interest by residents because some 50 attended the Tybolds TRA meeting on 14<sup>th</sup> April 2016 to discuss the Redevelopment.

It is clear that the residents have no confidence in Councillor Julian Fulbrook and by implication the administration of the present administration of Camden Council.

I dispute the Ban imposed arbitrarily by Mr Mark Reihil with out giving me any oppportunity to defend my self. I did visit the meeting to see who did attend. The two photos below are evidence that I submit.
