The Bikes Box is good for 2-3 bikes, the dimensions are (WxDxH): 1630mm x 780mm x 1200mm. It is finished in hot dipped-galvanised and polyester-coated 0.55mm steel, colour silver metallic, rain water-proof, galvanised steel floor plate, 20 year no rust perforation guarantee, securely bolted to the base.

The proposed location is in the front drive (marked in red), next to the boundary with No.3 Kemplay Road. The height of the box is lower than that of the boundary wall between the No.3 and No.5 Kemplay Road, hence the box will be largely concealed from view and certainly not obtrusive for the Residents of No.3 Kemplay Road
