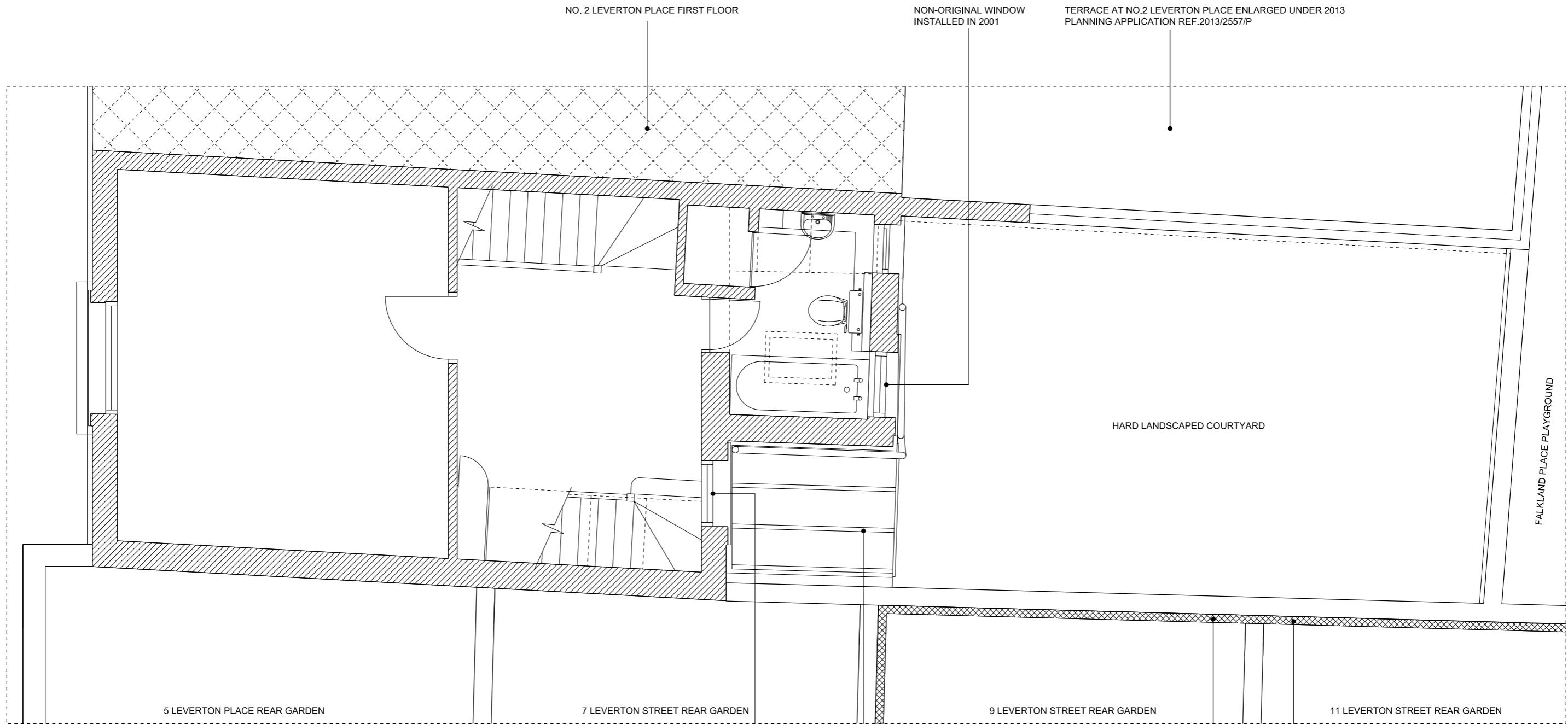

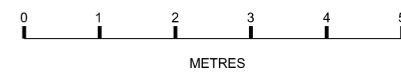
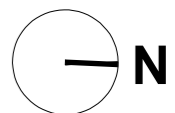


01 EXISTING FIRST FLOOR PLAN

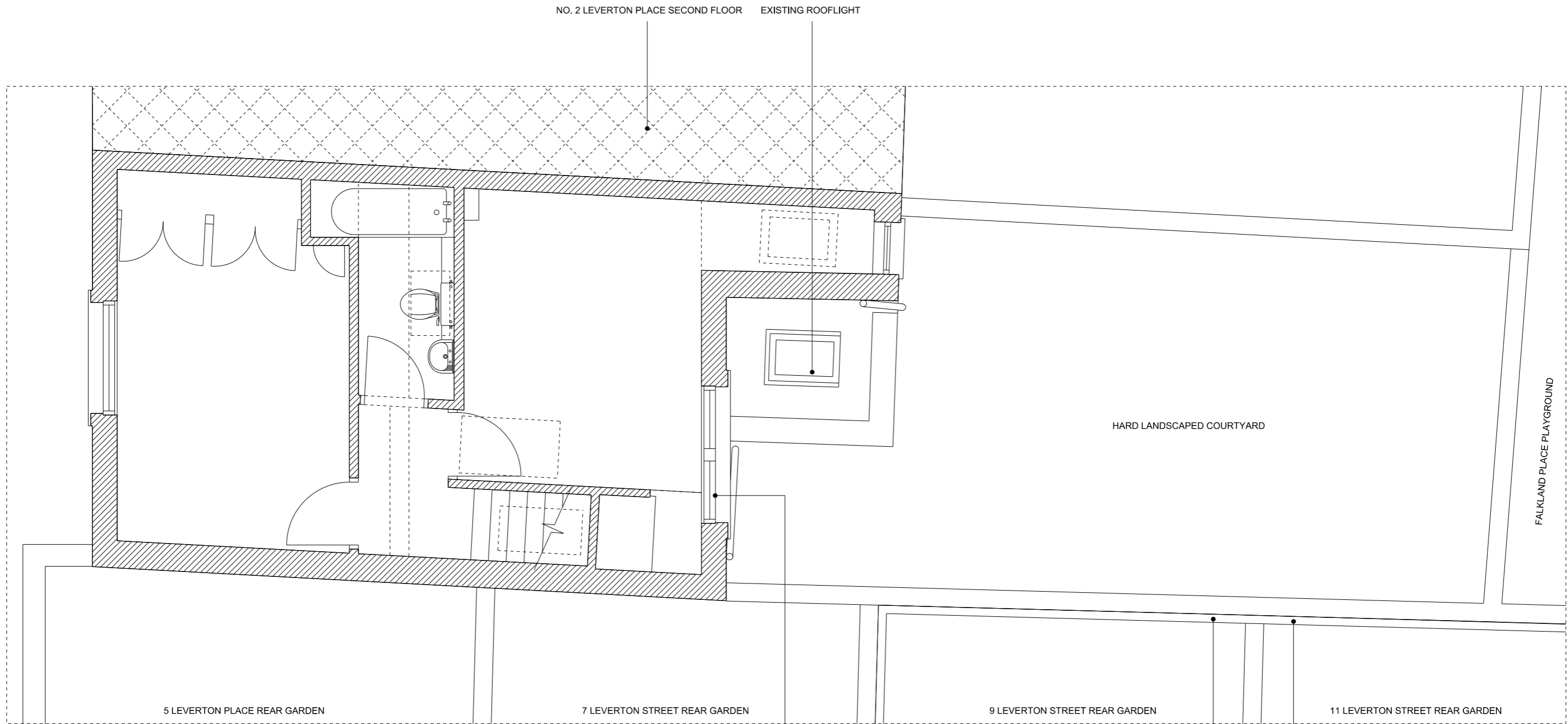

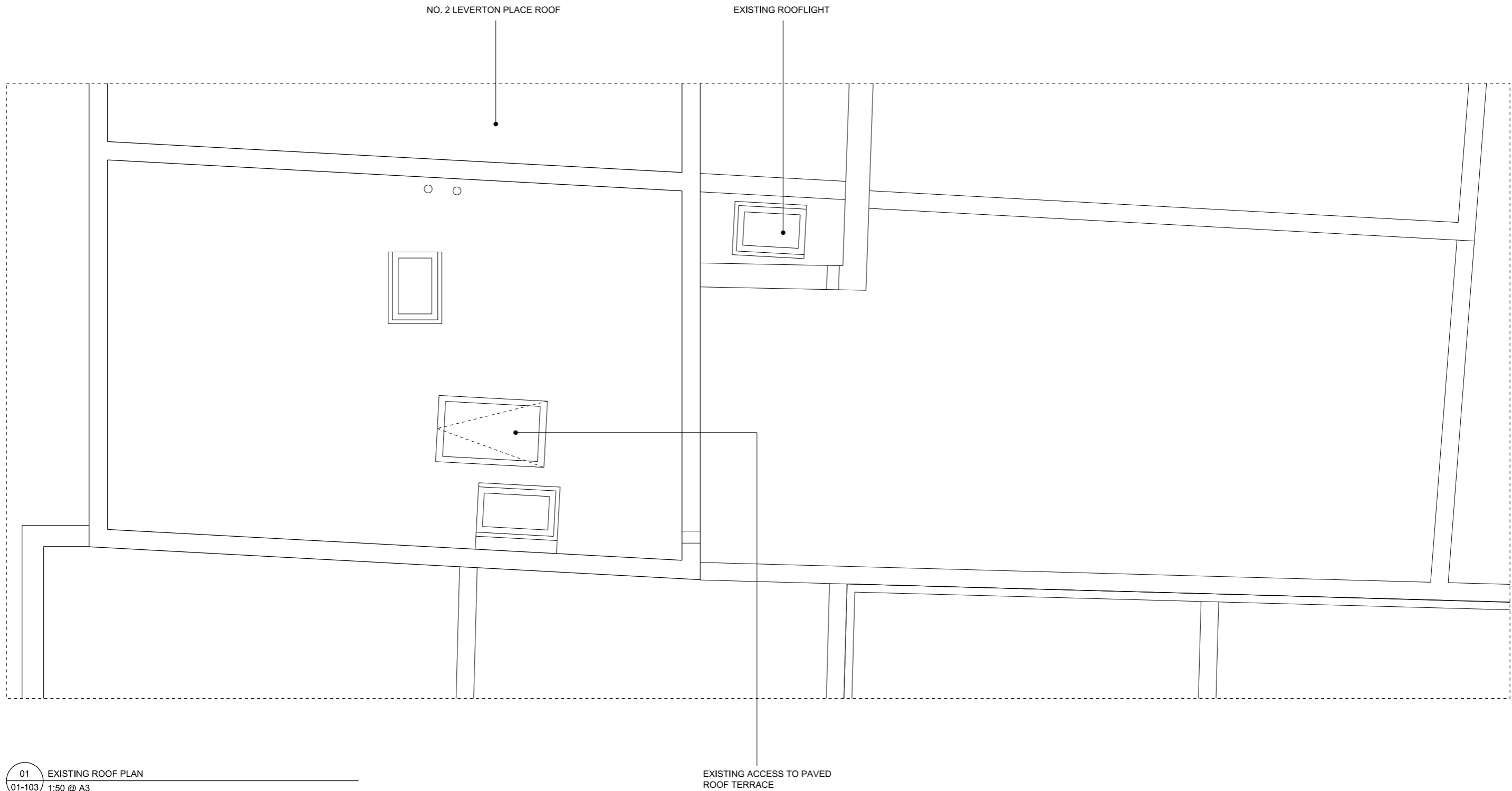

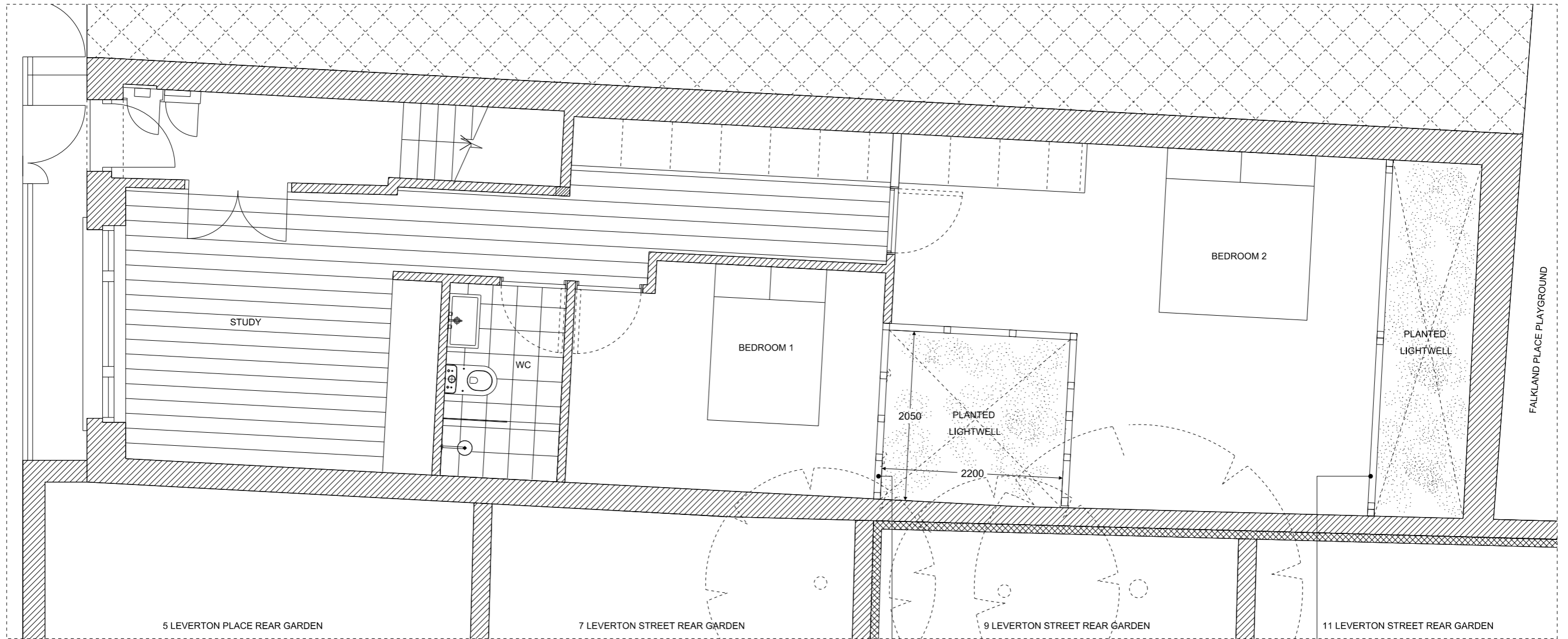


01 EXISTING ROOF PLAN

ROOF TERRACE



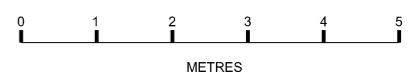

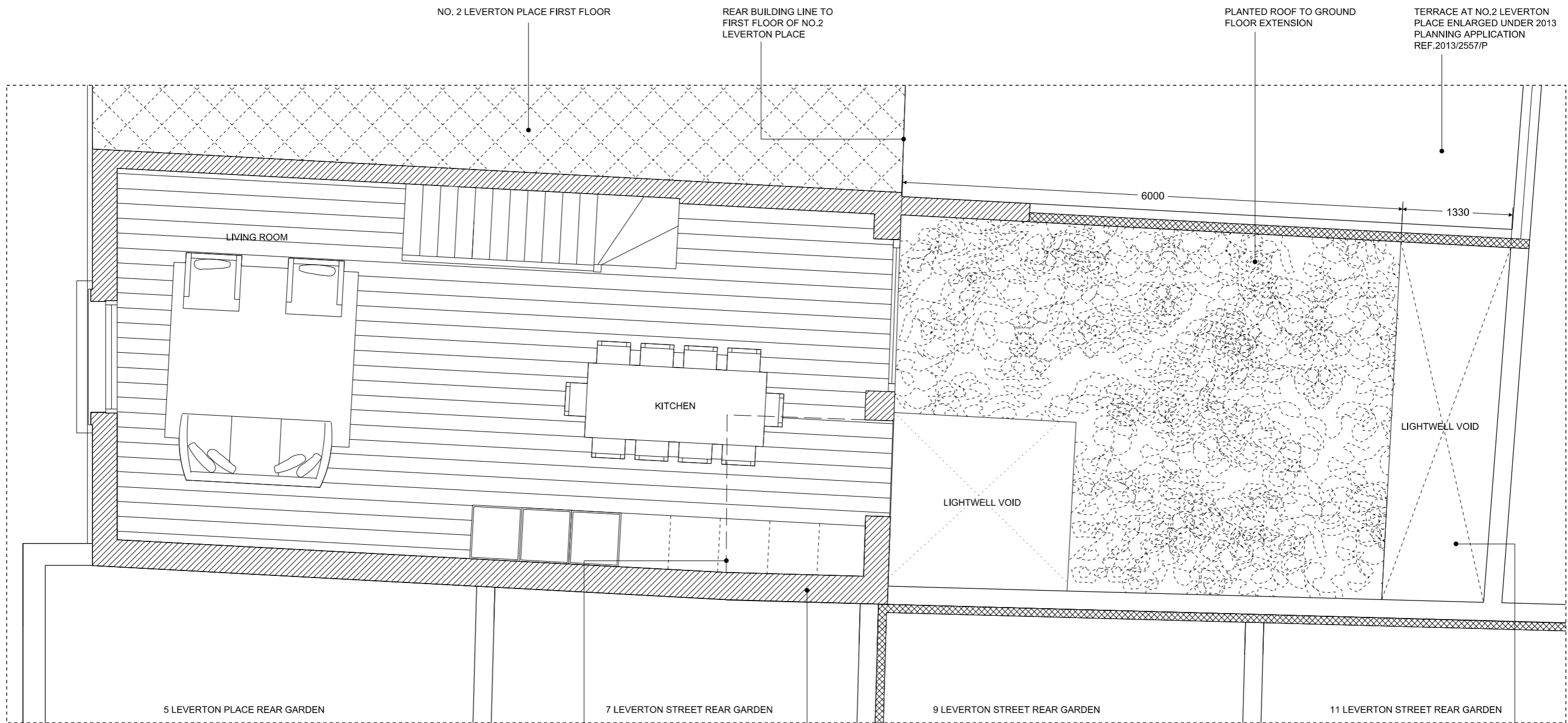

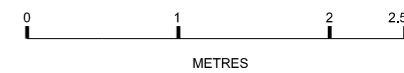
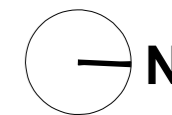


01 PROPOSED FIRST FLOOR PLAN

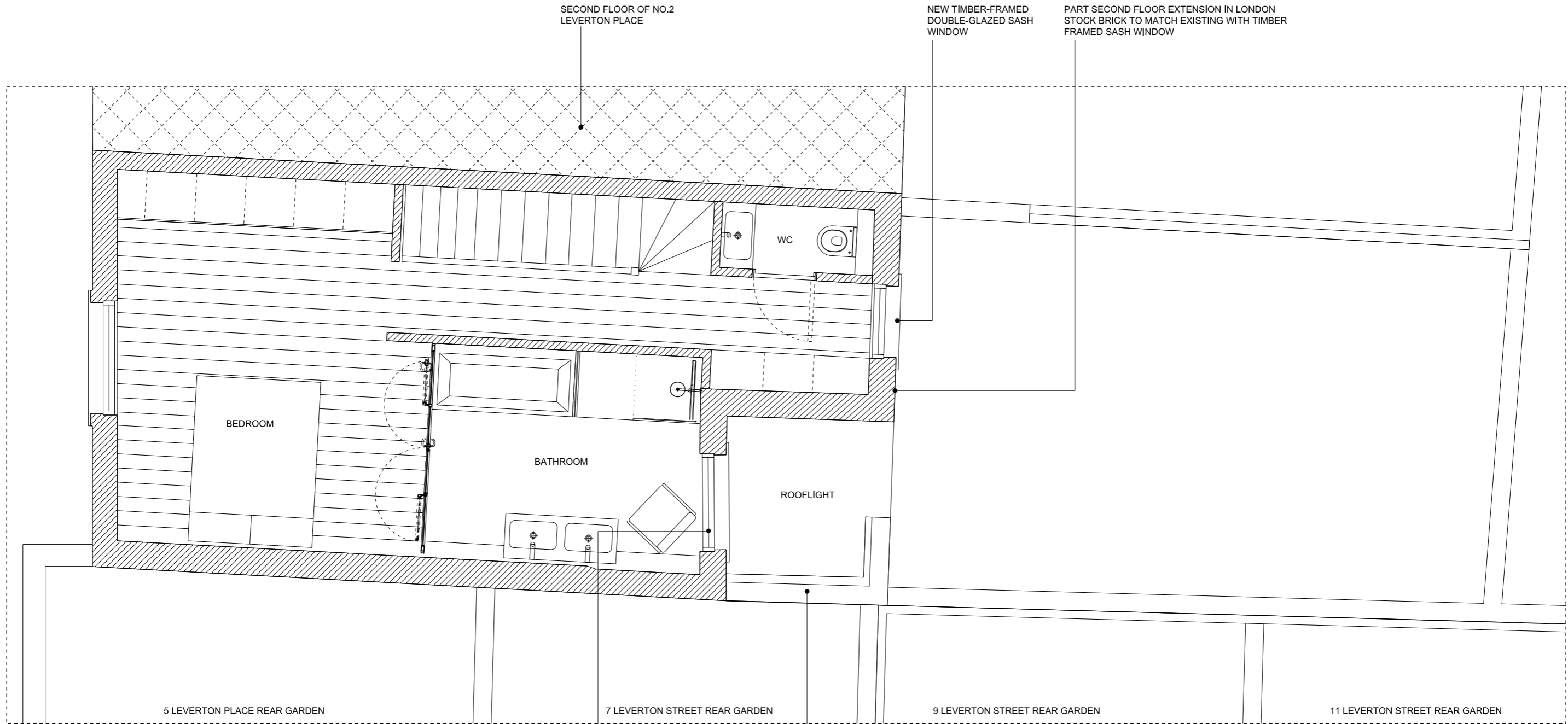
DOTTED LINE INDICATES EXISTING FIRST FLOOR FOOTPRINT

ADDITIONAL LIGHTWELL TO REAR OF PROPOSAL



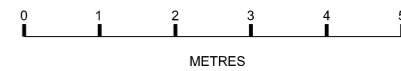
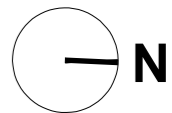

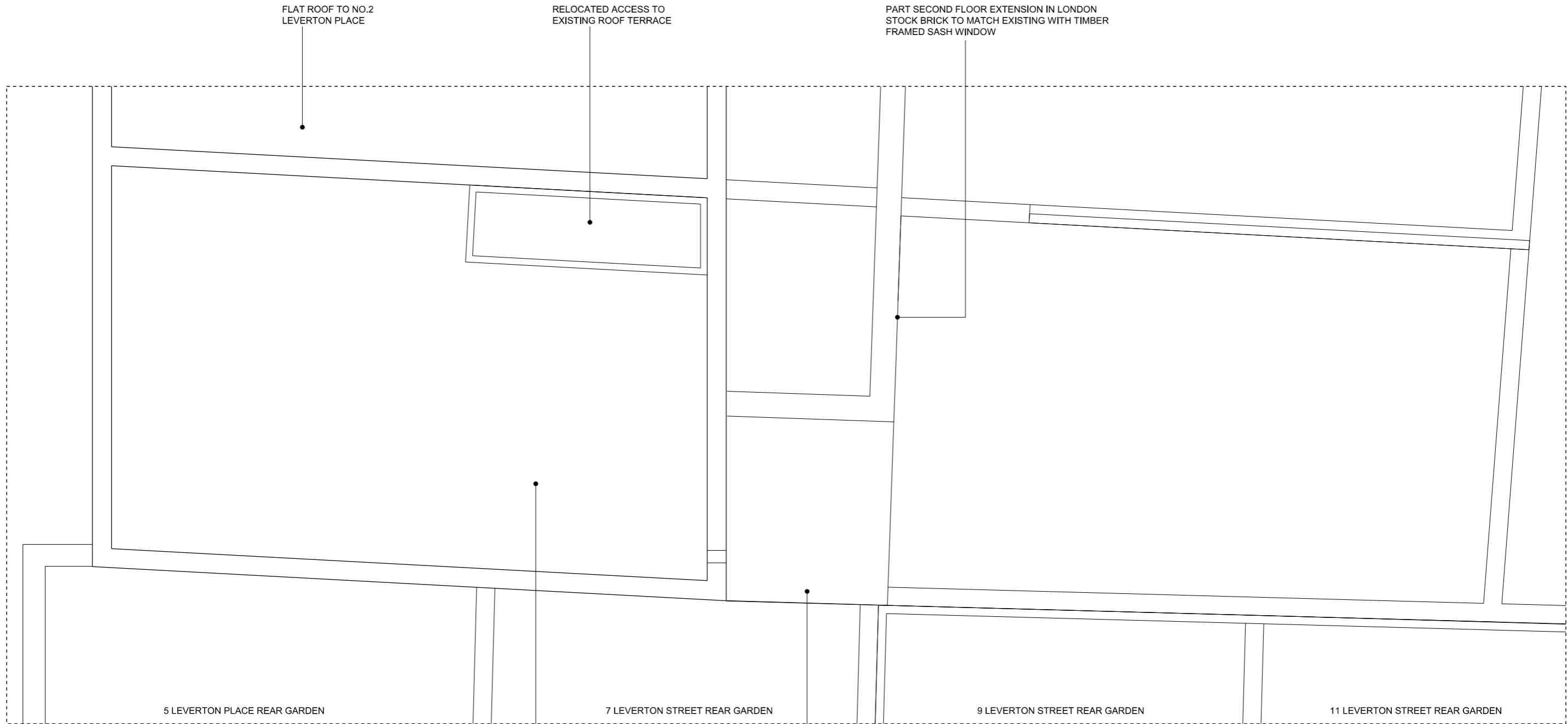

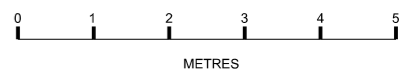

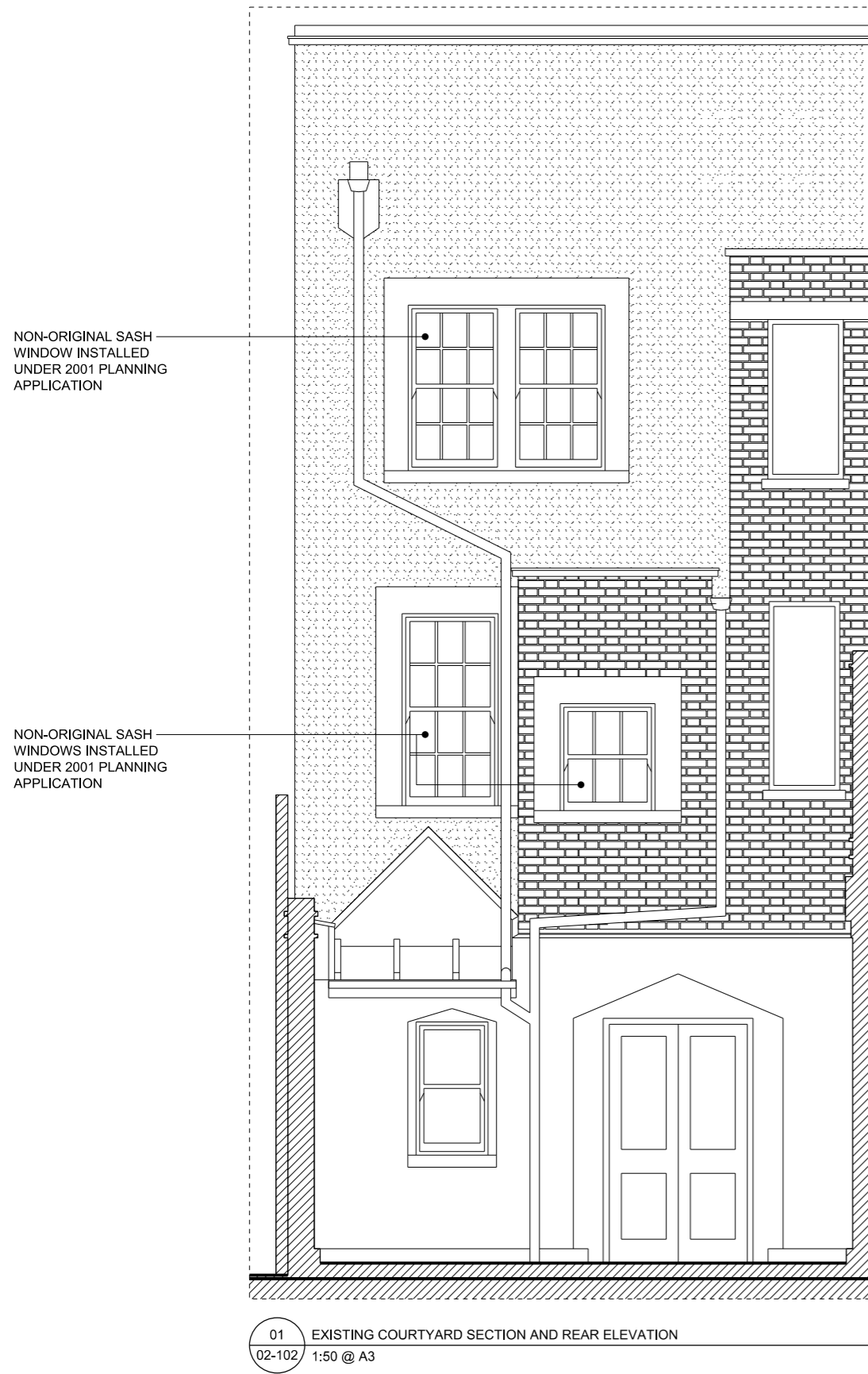

REAR ELEVATIONS SCREENED BY FENCING TO FALKLAND PLAY AREA PERIMETER

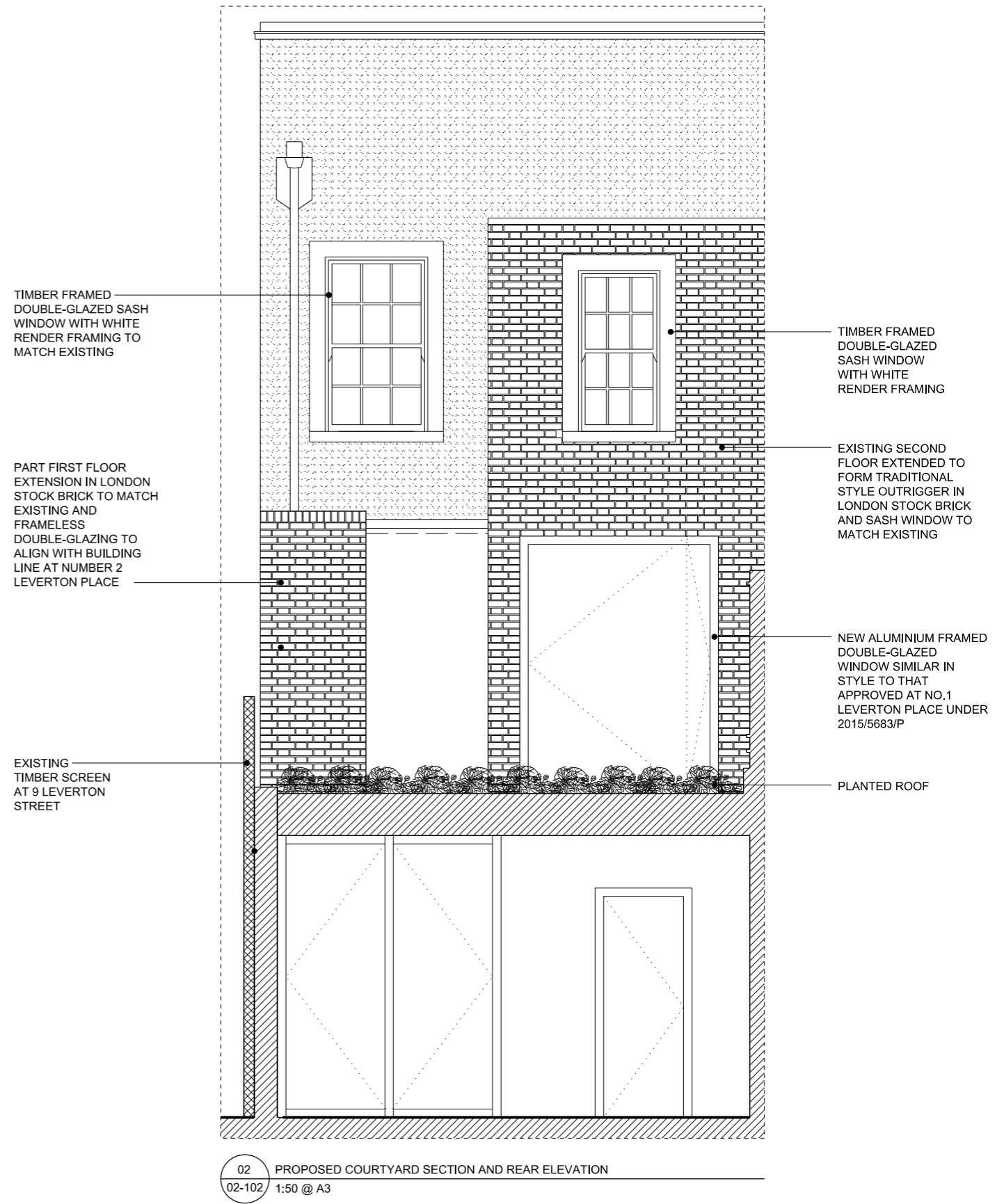

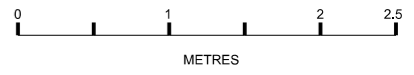
