
## Dear Kate

I live at Flat 6, Allingham Court, Haverstock Hill so my building is next to the building which is the subject of this planning application. I am very concerned about the proposals for a number of reasons, in particular safety, noise and lighting:

- This area has already seen an increase in crime and anti-social behaviour, and having people hanging out by the retail part of the building (which I believe is going to be a Sainsbury) is going to increase the noise and crime in the area.
- The proposed height of the building means that light for the flats in Allingham Court that face the building is going to be affected.
- The building is next to a very small road which has a blind spot when you cross it. If this road
  is going to be used more for delivery lorries etc then it will increase the chances of people
  getting knocked down.

I live at 164c Haverstock Hill.

I am very concerned by the lack of proper unloading facilities for this proposal. This will be hazardous to pedestrians and traffic on what is already a busy road that quite frequently gets blocked. Unless it is possible to provide full off street, off housing access, and off pavement provision Camden should turn down the application. If there is provision and the application can therefore go ahead, the permission should contain restrictions so that there are no sleeping hours or weekend deliveries due to the proximity to residential locations.

I'm writing to object to the planned Sainsbury's next to Belsize Park underground station on Haverstock Hill.

My objections are:

1/ The site is unsuitable for a shop of this kind, which requires frequent deliveries by truck, but provides no space for them to park without risking the safety of residents and blocking access to homes.

2/ The street already has several independent food retailers, who contribute in a large part to the sense of community. A chain supermarket such as Sainsbury's would jeopardise their business and negatively affect the character of the area.

I hope you will reject this unwanted plan.
