1 Reasons for granting consent

> The details of proposed shopfronts, awnings and signage, including their design, materials and finishes, are considered acceptable; the shopfronts are now embellished with details consistent with traditional shopfronts of this period and the



scholarly approach to their design is suitable to preserve the rich architectural quality of the building.

The proposed details are considered to preserve the appearance and special interest of this Grade 2* listed building. Special regard has been attached to the desirability of preserving the listed building, its setting and its features of special architectural or historic interest, under s.16 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

As such, the proposed development is in general accordance with policy CS14 of the London Borough of Camden Local Development Framework Core Strategy, and policy DP25 of the London Borough of Camden Local Development Framework Development Policies.

You are advised that conditions 4 (signage), part 5 (facing materials except roof tiles), 6 (railings), 9 (refurbishment to windows and doors) and 13 (staircase details) of listed building consent 2012/5591/L that require information to be submitted to the Council for approval remain outstanding.
