The Council has considered your application and had an appeal not been made to the Secretary of State, would have refused Listed Building Consent for the following reason(s):


Reason(s) for Refusal



- 1 The proposed arbour structure, by reason of its design, form, size and location, would harm the appearance, setting and special historic interest of the Grade 1 listed building, contrary to policy CS14 (Promoting high quality places and conserving heritage / conservation areas) of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.

- 2 The proposed replacement door, by reason of its design, location and associated loss of historic fabric, would harm the appearance and special historic interest of the Grade 1 listed building, contrary to policy CS14 (Promoting high quality places and conserving heritage / conservation areas) of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies
