The proposed arbour structure, by reason of its design, form, size and location, would harm the character and appearance of the host property, which is Grade 1 listed, and of the Bloomsbury Conservation Area. As such it is contrary to policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy and policies DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.
