Rear Garden:

Willow: Approximately 9.00m. Reduce crown by 20-30% ensuring screening skirt is preserved. Thin crown density by 20% and remove dead wood.

Reasons - to help manage the tree at a reasonable size for its location, increase light levels and help curtail the tree's sphere of influence in relation to walls and building whilst preserving the trees health and aesthetic value.

Leyland Cypress: Located in 26 Langbourne Avenue. Reduce the tree nearest to the boundary line by 20-20% as is practicable whilst maintaining a strong uniform hedge line.
