ENFORCEMENT NOTICE

OF GROUND FLOOR
152 CAMDEN HIGH STREET
LONDON
NW1 0NE

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to it that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. It considers that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the notice and the enclosures to which it refers contain important additional information.

2. **THE LAND AFFECTED**

Land at **152 CAMDEN HIGH STREET LONDON NW1 0NE** ("the Property") as shown, for the purposes of identification only, outlined in black on the attached plan.

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

The unauthorised installation of two solid roller shutters with a shutter box to the ground floor shopfront of the property.

4. **REASONS FOR ISSUING THIS NOTICE:**
 - a) It appears to the Council that the above breach of planning control has occurred within the last **4 years**.

 - b) The roller shutters and shutter box, by reason of their location, design and appearance and impact on natural surveillance, result in an incongruous addition which is detrimental to community safety and harms the character and appearance of the building and the Camden Town Conservation Area, contrary to the London Borough of Camden's Local Development Framework Core Strategy policy CS14 (Promoting high quality places and conserving our heritage), CS17 (Making Camden a safer place) and the London Borough of

Camden Local Development Framework Development Policies DP24 (Securing high quality design), DP25 (Conserving Camden's heritage) and DP30 (Shopfronts).

The Council does not consider that planning permission should be granted because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of three (3) months of the Notice taking effect:

1. Remove the roller shutters and the roller shutter box; and
2. Make good any damage caused to the front elevation.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **11 May 2016** unless an appeal is made against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.

The fee is payable twice to the "London Borough of Camden", as the Local Planning Authority.

If you wish to appeal under Ground (a), the fee payable to the "London Borough of Camden" should accompany the copy of the appeal form sent to the Council at the following address:

The fee is £172.00 for each new dwelling.

ANNEX
