drawing notes

All original doors, door frames and side panels to be retained are to be performance assessed and modified to suit current Building Regulations requirements for fire, smoke, acoustic performance etc - prior to repair and re-decoration.

Existing original dado and skirtings are to be retained, repaired and re-decorated. Any breaks are to be infilled with new and patched in, moulding to match original.

New ceiling to be provided along 1st floor corridor (west) - to be co-ordinated with door heights and fan lights.
