Proposal: Erection of a dormer to side roofslope.

The Council has considered your application and decided to grant permission subject to the following conditions:

Conditions and Reasons:

- 1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).



- 2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policies DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

- 3 The development hereby permitted shall be carried out in accordance with the following approved plans; Site Location Plan (Ref. PA1-007); PA1-001; PA1-002; PA1-003; PA1-005; PA1-004 Rev B; PA1-006 Rev P1; Design and Access Statement; and Planning Statement.

Reason: For the avoidance of doubt and in the interest of proper planning.

Informatives:

- 1 Reasons for granting permission:

The proposed side dormer is acceptable in terms of its proportions and positioning and respects the character of the host building and its setting within the Hampstead Conservation Area. The principle of inserting a dormer to the side roofslope is acceptable as this is a form of development prevalent along Cannon Place, with examples of similar dormers present at numbers 7, 9 and 15. The proposed dormer is also appropriate in terms of its form and scale, and in line with CPG1 guidance being set precisely 500mm in from the side roofslope edges. The proposed dormer would also sit centrally within the side roofslope and so is appropriate in terms of its positioning. With regards to its detailed design the proposed dormer mimics the existing dormers in the immediate vicinity, featuring a similar fenestration pattern - in number, form, scale and pane size - and so would read entirely cohesively within the existing roofscape. As a result of its position at the side of the property, the dormer would be visible in in views from the public realm on Cannon Place and in oblique views from neighbouring properties, but given that it is set in sufficiently from the front roof edge particularly, it would still have a very limited visual impact.

Due to the size and location of the proposed dormer, the development would not harm the amenity of any adjoining residential occupiers in terms of loss of light, outlook or privacy. Whilst the development would create new windows these would not be closer than the relationship experienced by existing windows, and therefore this harm would be limited and not significant.

No objections were received prior to making this decision, and one comment in support was submitted. The planning history of the site and relevant appeal decisions were taken into account when coming to this decision.

Special attention has been paid to the desirability of preserving or enhancing the

character or appearance of the conservation area, under section 72 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposed details are in general accordance with policies CS5 and CS14 of the London Borough of Camden Local Development Framework Core Strategy, and policies DP24, DP25 and DP26 of the London Borough of Camden Local Development Framework Development Policies. The proposed development also accords with policies 7.4 and 7.6 of the London Plan 2016; and paragraphs 14, 17, 56-66 and 126-141 of the National Planning Policy Framework.

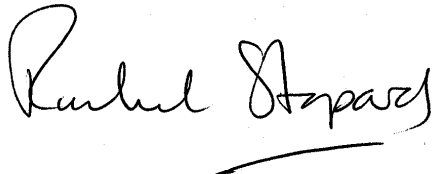
- 2 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts which cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. - 3 Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You are advised to consult the Council's Compliance and Enforcement team [Regulatory Services], Camden Town Hall, Argyle Street, WC1H 8EQ (Tel.
