Proposed installation of an external front signage at entrance to house number 27 and 28 Russell Square.
The purpose of the signage is mainly to aide wayfinding for students and visitors to the College's premises at Russell Square.
The signage shall be constructed to a brushed stainless steel finish with engraved black in-filled text. Each of the proposed 2 signage (one at the entrance of each house) shall be size 620mm x 260mm x 20mm. The signage shall be wall mounted on block fixings at approximately 1700mm high from entrance step landing finish floor level.
