3. Description of the Proposal

Please describe the proposed development including any change of use:

As a result of the recent merger with Ch5, the Public Service Broadcaster, there will be increased personnel on site who will be accommodated in the recent site development which is currently underway. As Viacom has been successful in renting the three buildings next to this site to form a campus, having one front door for the whole company is both sensible in terms of staff security, cost (manned security) and business process.

Staff pass via the main entrance of 17-29 Hawley Crescent into the Elephant Courtyard and access the Elephant House, the Lock and the Brewery Building. However this means that the through-put via the existing revolving door needs to be increased to prevent a build-up of staff on the pavement.

In addition to this practical change we have recently carried out a high level security review to assess our staff security in the light of the current threat level and our position as a US based TV broadcaster.

Various recommendations have been made, not least of which is the replacement of the existing glass in our reception area and revolving door with a Ballistic rated glass, replacement of our existing internal turnstiles with revolving doors and replacement of the pedestrian front door with a circle lock door on both the front elevation and also in-line with the new internal revolving turnstile replacement doors.

The proposed plan is to replace the existing revolving door with two slightly smaller doors, currently users access the revolving door one at a time, as it is in between a one and two person segment, the two new doors will only accommodate one and the speed of entry is greater increasing the ingress significantly, and replacement of the external swing pedestrian door with a circle lock door as per the plans attached.

The front elevation will not dramatically change, and will not move outside the current curtilage, it is designed to sit within the current building extent regarding the space plan.
