Please describe the proposed development including any change of use:

We propose to secure the site and prevent future unauthorised occupation by placing two temporary accommodation units on site and stationing property guardians there. We intend to install the units on or around the date that squatters currently in occupation leave the site and will remove them by no later than the earlier of a) when once plans to bring the property back into use are approved and construction commences and b) 3 years from the date the units are placed onsite.

Each of the units will be no larger than 45 feet / 13.7 meters (length), by 15 feet / 4.6 meters (width), by 12 feet / 3.7 meters (height) and their proposed placement on the property is noted on the site map included in this application.

It should be noted that this mostly open, half acre property was - despite security patrols - reoccupied within weeks of a previous eviction and it is almost certain that squatters will return unless a continuous onsite presence is provided for. In addition, unimpeded access is and will be needed in order to develop plans to bring the site back into use and to complete remedial work that has been identified as necessary by the owner and Camden Council.
