Mature tree. This tree overhangs the neighbouring property. The tree has a large amount of dieback in the upper canopy. This can be an indication of root problems or decay fungi. I was unable to inspect the base of the tree to determine the problem. It is unlikely that the Local Planning Authority would grant consent to prune the tree back to the boundary line. This is due to the size of the wounds being put into the tree and because it would unbalance the tree and its root system may not be able to cope with this. It would be better arboricultural practice to remove the deadwood and reduce the whole tree, this would have more of an impact on the overhang and general size of the tree. The suggested works are: To remove the dieback/deadwood, reduce the overall height and the lateral spread all round by 2.5m.
