T1 Sycamore x 1

Large, mature tree. The main stem on this tree is in decline. The branches at the top are dead, the top half of the stem is heavily decayed and daylight can be seen through the cavity. The lower branches on this stem have hardly any buds or leaves opening in comparison to the other stems. Removal of the stem down to 3.5m above ground will leave a hole in the crown and expose the remaining crown to the wind. To counter this exposure the remaining crown should be reduced. The suggested works are: To remove the dying stem down to 3.5m above ground, reduce the height and the lateral spread of the remaining crown by 2 - 2.5m all round.

Rear left

T2 Evergreen Magnolia x 1

Juvenile tree. This tree is encroaching on the neighbouring property. The suggested works are: To reduce and reshape by 1m all round.

## 7. Identification Of Tree(s) And Description Of Works

Rear

T3 Purple leaf Plum x

Early mature tree. This tree is growing out over the lawn and outgrowing its location. The suggested works are: to reduce the height and the lateral spread all round by 1 - 1.25m, retain as much privacy screening as is possible.
