3. Description of the Proposal

Please describe the proposed development including any change of use:

This planning application consists of two parts: A, the installation of a ventilation system to address an on-going issue of overheating in the summer and, B, alternations to the back door. For both issues, permission has been sought from our landlord, Camden Council, and the owner of the property, One Housing Ltd. Both parties have agreed and a license to alter will be issued subject to planning permission.

A. During summer months, temperatures in the nursery regularly surmount comfortable levels, with children's classrooms, kitchen, office and bathrooms particularly affected. Classrooms often reach around 30 degrees, and bathrooms and kitchen even in excess of this. After renting mobile coolers for the past years, the management of the nursery, supported by its parent committee, decided to take more sustainable and cost efficient measures. We propose therefore,

to install air-conditioning to the office and kitchen on the ground floor, the bathrooms on the first floor as well as the staff room on the second floor. Three air-conditioning compressors are to be located on the external flak wall to the right of the front entrance, one on each floor in similar colour, or painted to match the colour of the brickwork (see attached files 'MXZ-4D72VA brochure and 'MXZ-4D72VA drawing).

and to install a fresh air internal mechanical ventilation system to the ground, 1st and 2nd floor childrens classrooms requiring two 150mm round openings per classroom (6 in total) covered by ventilation grilles on the external wall facing eastwards (see attached files 'VL-100U5-E drawing for details and dimensions).

B. Alteration to the ground floor external double door to south elevation to construct a brick wall to form a new narrower doorframe opening and replace with a 1.2m wide single door with window above. New brickwork, frame and door to match the existing. The purpose of this is to create space for a narrow sidebar in the lobby.
