Installation of secondary glazing to sash windows at all floor levels

The Council has considered your application and decided to grant Listed Building Consent subject to the following condition(s):

Conditions And Reasons:

1 The works hereby permitted shall be begun not later than the end of three years from the date of this consent.

Reason: In order to comply with the provisions of Section 18 of the Planning (Listed Buildings and Conservation Areas) Act 1990.



2 The works hereby approved are only those specifically indicated on the drawing(s) referred to above.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 of the London Borough of Camden Local Development Framework Development Policies.

All new external and internal works and finishes and works of making good to the retained fabric, shall match the existing adjacent work with regard to the methods used and to material, colour, texture and profile, unless shown otherwise on the drawings or other documentation hereby approved or required by any condition(s) attached to this consent.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 of the London Borough of Camden Local Development Framework Development Policies.

Informative(s):

1 Reason for granting Listed Building Consent:

The proposals seek permission to install secondary glazing to 9no windows to reduce the levels of heat loss and traffic noise.

The works will not impact upon existing features of interest internally, are seen as temporary and reversible and as such will not harm the special interest of the building. Secondary glazing is not proposed to windows which retain historic shutters and shutter boxes.

No.33 is listed grade II and sits to the end of the terrace listed as 'numbers 33-49 and attached railings'. The terrace dates to c1823-26 and designed by Thomas Cubitt. It is constructed of yellow stock brick with stucco at ground floor of three storeys with basement. No 33 has a tripartite sash at ground floor and to the first floor has an enlarged opening with French doors and cast iron balcony.

Listed Building Consent and Full Planning Permission are being assessed to carry out a number of internal and external alterations to the lower and upper maisonettes (2016/0271/L & 2015/6753/P).

No public consultation was necessary for this application and the site's planning history was taken into account when coming to this decision.

Special regard has been attached to the desirability of preserving the listed building and its features of special architectural or historic interest, under s.16 of the Listed

Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposal is in general accordance with policy CS14 of the London Borough of Camden Local Development Framework Core Strategy, and policy DP25 of the London Borough of Camden Local Development Framework Development Policies. The proposed development also accords with policy 7.8 of the London Plan 2015, and paragraphs 14, 17, 56-68 and 126-141 of the National Planning Policy Framework.

- Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts which cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. - Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974.
