Proposed development consists of altering four of the windows to doors of this penthouse flat leading onto the terrace to doors. The proposal also consists of changing the windows from single glaze to double glaze due to noise. The bedroom window will be converted into a door so this bedroom will have access to terrace like other bedroom. Two other windows in the living/kitchen area will be opened into doors. Changes proposed will not alter the aesthetics of the brick wall of façade or of the top half of the window, and height of the windows to be converted to doors will be maintained. Only the bricks wall from window base to floor will be remove to create a doorway. Given that this flat is on the 7th floor and all windows lead onto a balcony which is 1.3 m wide all proposed changes will not be visible from any point at street level. Photos attached.
